Terms & Conditions:

1. Shree Vishwakarma Mewada Suthar Samaj (Gujarat) (Ambaji Sanstha) shall be considered the organizer of the event.
2. Exhibitor means the company / institute / individual who has booked the stall and filled the application form.
3. The exhibitor shall display only the brochures / products mentioned in the application form.
4. All expenses related to stall interior, decoration, product display, and transportation of sales personnel shall be borne solely by the exhibitor.
5. Responsibility for obtaining insurance for the exhibitor's products shall lie entirely with the exhibitor.
6. For each 3x3 stall, 1 table, 2 chairs, 1 plug point (5A), and 3 spotlights will be provided. Additional lights, electrical points, chairs, or tables will be charged extra.
7. Additional charges will be applicable for all extra facilities availed by the exhibitor.
8. In case of fire, storm, riot, or any natural or unnatural calamity, Shree Vishwakarma Mewada Suthar Samaj (Gujarat) shall not be responsible in any manner for any loss or damage to goods.
9. Participants must take possession of the stall by 5:00 PM on the day prior to the commencement of the event and must vacate the stall by 8:00 PM on the last day of the event.
10. In case of damage to or theft of stall property, the market value of the property shall be recovered from the concerned exhibitor.
11. Upon signing this application, it shall be deemed that the exhibitor has read, understood, and accepted all the terms and conditions.
12. In case the exhibitor cancels the stall booking, the advance amount paid to the organizer shall be retained by Shree Vishwakarma Mewada Suthar Samaj (Gujarat) and shall not be refunded.
13. The organizer shall have full rights to allot or make changes to any stall.
14. The organizer reserves the full right to cancel or postpone the event at any time due to circumstances or time constraints, without prior notice.
15. A payment of 25% is required at the time of booking. The remaining 75% must be paid on or before 16th March 2026 by cheque or transfer, drawn in favor of Shree Vishwakarma Mewada Suthar Samaj (Gujarat).
